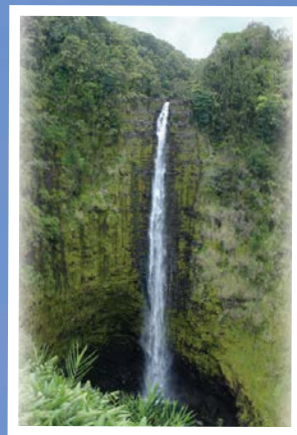
Join The Inspirations, Dr. Joe Arthur, and Jonathan Wilburn on this Hawaiian Cruise Adventure.

Our journey begins on Saturday in beautiful Honolulu, Hawaii, where we board the luxury cruise liner Pride of America and set sail.



Sunday morning we dock at the beautiful port city of Kahului, Maui. Enjoy the waves and beach, play a round of golf at one of the island's world-renowned courses, or ascend the slopes of the dormant volcano Haleakala to experience a breath-taking sunrise.

Tuesday morning we call on the port of Hilo on the "Big Island" of Hawaii, where you will find spectacular scenery and unspoiled nature. Explore the nearby Hawaii Volcanoes National Park and the waterfalls along the Hamakua Coast. In the evening the ship will sail by Mount Kilauea, and weather permitting, you will see red lava flowing into the ocean.



Wednesday morning we arrive in Kona on the "Big Island" of Hawaii, also known as the "Gold Coast." In Kona you may choose to visit the Captain Cook Monument, Pu'uuhonua O Honaunau (Place of Refuge) National Park, or the Mokuaikaua Church.



Thursday morning the ship docks in Nawiliwili, Kauai, made famous in the musical "South Pacific". With its spectacularly lush vegetation, jagged mountains, capes and dreamy beaches, Kauai may be Hawaii's most beautiful island. Late Thursday afternoon we experience a traditional Hawaiian luau at sundown, to include delicious food and live entertainment.

On Friday you can explore Kauai and experience it's fragrant fern groves and plunging waterfalls at Waimea Canyon, the "Grand Canyon of the Pacific."

On Saturday morning we arrive back in Honolulu as our beautiful cruise comes to an end. We will disembark the ship and travel to Pearl Harbor for a tour of the Arizona Memorial. This afternoon, we will say goodbye to our new friends, and transfer to the airport for our return flight back to the mainland. Aloha!

General Conditions

Deposit Requirements: A deposit of \$300.00 per person is due with registration to secure accommodations. An additional payment of \$1000.00 is due by May 10, 2024. The balance is due July 15, 2024. Deposits may be made by personal check, money order, or credit card (Visa/MC/Discover). Credit card payments beyond the initial deposit will be accepted for an additional 3% non-refundable fee. **Reservations received after July 15, 2024 may incur additional charges due to supplier contract terms.**

Cancellations and Refunds: If a passenger cancels his or her cruise reservation there will be a cancellation fee of one hundred-fifty dollars (\$150) per person up until 120 days before departure. For cancellations within 119-91 days before departure the cancellation fee will be 25%. For cancellations within 90-61 days before departure the cancellation fee will be 50%. There will be no refund for cancellations within 60 days of departure, no-shows or partially completed cruises. All cancellation requests must be addressed to Templeton Tours in writing. **Trip cancellation insurance is recommended.**

Identification: US citizens are required to present a government-issued photo I.D. which includes a passport or a valid driver's license with a photo. Citizens of countries other than the US should contact their respective embassies or US Immigrations for applicable regulations. Children under 18 years of age traveling without both parents must bring a notarized letter of consent from the absent parent(s), giving permission for them to leave the country with a specified adult guardian.

Embarkation: The Pride of America sails from Honolulu, Hawaii at 7:00PM on Saturday, November 16, 2024. Embarkation begins at 1:00PM. You must be on board no later than 2 hours before sailing.

Disembarkation: The Pride of America returns to Honolulu, Hawaii at 7:00AM on Saturday, November 23, 2024. Allow 1-2 hours for disembarkation, customs and immigration formalities.

Passage Contract: The attention of the passengers is specifically directed to the conditions of transportation set forth in the passage contract of the ticket of Norwegian Cruise Lines General Sales Agents and Operators.

Accommodations: Prices are based on two full-paying passengers per cabin. Single cabins are available at two times the published rate. Tour participants without a roommate will have to pay the single supplement if Templeton Tours cannot find a roommate for you. Pricing for 3rd and 4th passengers in a cabin is available upon request and subject to availability. Specific cabins will be assigned by the cruise line within the selected category once full payment is received.

Fare Inclusive: Your cruise rate includes ocean transportation, accommodations in the category of your choice, meals onboard ship, Luau Dinner & Show, Pearl Harbor tour and transfer to the Honolulu airport on November 23, 2024.

Registry: Pride of America is registered in the USA.

Cruise Ship Baggage Allowance: Two medium size suitcases (max. 50 lbs each) plus one carry-on bag and personal item per person.

Not Included: Airfare from your home city to Honolulu, transfers from the airport to the pier in Honolulu, pre or post cruise hotel accommodations. Gratuities onboard the ship to be made at your discretion.

Disabilities: Any physical disability or medical condition that requires special treatment or attention must be reported to Templeton Tours Inc. when the reservation is made. Templeton Tours, Inc. and Norwegian Cruise Lines have the right to refuse or revoke passage to anyone who, in its judgment, is in a physical or mental condition unfit for travel or who may require care beyond that which Templeton Tours, Inc. or Norwegian Cruise Lines can provide. Norwegian Cruise Lines also reserves the right to deny participation in certain activities based on past or present medical conditions. All passengers with disabilities must be self-sufficient and should travel with a passenger who will provide any assistance needed during the cruise or in the event of an emergency. Passengers who use a wheelchair must provide their own small, collapsible type and may find certain areas of the ship inaccessible.

Price Changes: Tour conditions and cruise fares are based on cruise fares in effect at the date of and during the tour. All rates are quoted in US dollars and are based on tariffs and costs in effect as of Feb, 2024. Fuel surcharges are not currently in effect. Templeton Tours reserves the right to pass along any fuel surcharges implemented by the cruise line.

Responsibility: Cruise transportation of passengers and their baggage is governed by the terms and conditions printed on the Passenger Ticket Contract. Responsibility for The Cruise Lines does not extend beyond the vessel. TEMPLETON TOURS and The Cruise Line expressly disclaim any responsibility for personal injury or property damage arising out of the acts or negligence of any air carrier, hotel, or any person rendering any of the services offered in addition to the ship's cruise and shall not be responsible for any damage or inconvenience caused by late air, car, or motorcoach arrivals nor for loss or damage to baggage or other property of the passenger occurring off the vessel. Loss or damage to baggage must be reported to the responsible airline, land carrier, or ship personnel prior to leaving the area of responsibility.
