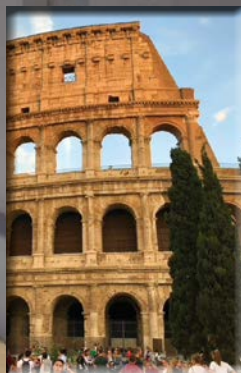

Join Dr. Ralph Sexton on this once-in-a-lifetime tour revisiting sites of the Apostle Paul's missionary journeys. Dr. Sexton will be your host and Bible teacher for this unforgettable journey.

Our adventure starts with an evening flight from Charlotte to Rome, Italy. Upon arrival in Rome, we will enjoy a local lunch before checking into our hotel. You will then have some free time to explore with dinner provided at the hotel.

Friday morning, we will begin our tour of the Eternal City of Rome. Sites to be visited include The Colosseum, the Arch of Titus, and the Roman Forum. After lunch, we will visit the ruins of the Mamertine Prison where it is said that Paul was imprisoned for his beliefs. Tonight we will enjoy a traditional Italian meal in at a local restaurant.

Saturday morning, we will visit the cathedral of St. Paul Outside the Walls, the location of Paul's final resting place. After an early lunch, we will drive by Circus Maximus, Piazza Venezia, and the monument of Vittorio Emanuele, on our way to Civitavecchia to board the brand new Sun Princess, our home for the next seven nights. With over 20 dining options, there's something for every taste on board.

The first stop of our cruise will be Naples, Italy, the port of the once thriving and sophisticated Roman city of Pompeii. Here we will step back in time to get a glimpse of everyday life in the ancient world. We will take a guided tour of this famous city that lies at the foot of Mt. Vesuvius.



Monday is a day at sea with a morning Bible study where Dr. Sexton will introduce us to the Apostle Paul.

On Tuesday morning, we arrive at Chania, Crete, the second largest city in Crete and one of the most beautiful cities on the island. The day is at your leisure to explore the ancient city of aptera and enjoy the panoramic view of the venetian harbor.

Wednesday is another relaxing day at sea. Dr. Sexton will lead us in a Bible study to prepare us for our time in Ephesus & Athens. The balance of the day can be spent enjoying the luxuries of our cruise ship as we cruise through the Mediterranean.

Thursday we call on Ephesus, the greatest city in Asia Minor during the Roman Empire and home to one of the Seven Churches (found in book of Revelation 2-3). Ephesus was the largest city the Apostle Paul visited, and the city where he confronted the followers of Diana (Acts 19:28). Just outside Ephesus we will also visit the Basilica of St. John, erected over the Disciple John's grave by Emperor Justinian.



Friday we travel to Mykonos. Here in this stunning city you can stroll around the town, take in the breath taking views, gaze at the architecture, and shop for the perfect souvenir to

remember this once in a lifetime voyage.

On Saturday we arrive at the port city Piraeus, Greece, where we will depart by bus for ancient Corinth. There we will view the remains of the fabled city to include; the ruins of the Temple of Apollo and the famous Bema, also known as the judgement seat. At this site Paul defended himself before proconsul, Gallio. (Acts 18:12). After lunch we will travel to Athens to check-in our hotel and enjoy a traditional Greek dinner.



Sunday, we explore the historic city of Athens, the birthplace of civilization. We will begin with a visit to the Acropolis and Parthenon. Nearby we will visit Mars Hill, where Paul addressed the Athenians. (Acts 17:22-

34) While there, Dr. Sexton will teach about the "unknown god." We will also see the Ancient Agora, Tower of the Winds, Herodes Atticus Theater, Theater of Dionysus, and the



Temple of Zeus while in Athens. After lunch there will be time for shopping in the old Plaka district.

Monday morning, we depart our hotel in Athens for the return flight home, having witnessed marvelous and historic wonders of our Christian faith.

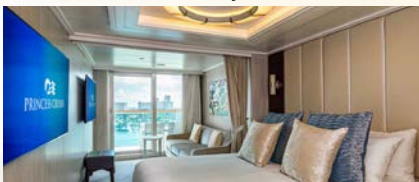

Credit card payments beyond the initial deposit will be accepted for an additional 3% non-refundable fee.

CANCELLATIONS AND REFUNDS: If a passenger cancels his/her tour membership there will be a cancellation fee of one hundred twenty-five dollars (\$150.00) per person up until 91 days before departure. For cancellations 90-74 days before departure the cancellation fee will be 25% of the tour cost. For cancellations 74-57 days before departure the cancellation fee will be 50% of the tour cost. There will be no refund for cancellations within 56 days of departure, no-shows, or partially completed tours. All cancellation requests must be addressed to Templeton Tours in writing. Trip cancellation insurance is recommended.

FARE INCLUSIVE: Roundtrip coach class airfare from Charlotte, NC (CLT). Two (2) nights hotel accommodations in Rome & Athens. Seven (7) nights onboard the Celebrity Ascend.
